## **Product Overview**

The COA-15/RJ is a DB-15M to RJ45 Breakout Adapter used to convert GPIO xNode General Purpose Outputs (GPOs) to an RJ45 connector. The COA-15/RJ also breaks out the GPIO ports 5 GPIs to their own RJ45 jack for ease of installation. Using the **Broadcast Tools COA-15/RJ**, DB-15M to dual RJ45 adapter you can easily interface the GPO output from a GPIO xNode port with the optional **Broadcast Tools Box O' Relays 6** via standard Cat5/6 cabling converting the port's 5 GPOs to 5 isolated SPDT dry contact closure outputs on pluggable screw terminal block.

## Inspection

Please examine your **COA-15/RJ** carefully for any damage that may have been sustained during shipping. If any damage is present, please notify the shipper immediately and retain the packaging for inspection by the shipper. The package should contain the **COA-15/RJ**. Manuals can be downloaded from our web site.

# Installation/Operation

The **COA-15/RJ** connects with your equipment through an RJ45 cable. Follow the labels in this manual and on the circuit board for all connections.

- Step 1: Plug the 15-pin male D-sub connector on the COA-15/RJ into the GPIO port.
- Step 2: Tighten the two 4–40 mounting screws on the COA's 15-pin D-sub connector's mounting ears, securing the **COA-15/RJ** to the GPIO port's mating connector.
- Step 3: Connect the user-supplied Cat5 cabling to the RJ45 jacks on the **COA-15/RJ** labelled "J2" "Out"
- Step 4: Connect the other end of the Out/GPO RJ45 Cat5 cabling to the destination device, such as the optional **Broadcast Tools Box O' Relay 6**, or into a user-supplied punch block.
